# The scope of this investigation

#### **Goods Concerned**

This investigation covers Aluminium Extrusions exported from People's Republic of China (PRC), described as:

The goods under investigation are bars, rods, profiles (whether or not hollow), tubes, pipes; unassembled; whether or not prepared for use in structures (e.g. cut to length, drilled, bent, chamfered, threaded); made from aluminium whether or not alloyed, containing not more than 99.3% aluminium.

The product concerned is commonly referred to as 'aluminium extrusions', referring to its most common manufacturing process even if it can also be produced by other production processes such as rolling, forging or casting.

These Aluminium Extrusions are currently classifiable within the following commodity code(s): **76041010**, **76041090**, **76042100**, **76042910**, **76042990**, **76081000**, **76082081**, **76082089** and **76109090**.

In this pre-sampling questionnaire, these goods will be referred to as 'the goods concerned'. Any reference to 'goods concerned' in this pre-sampling questionnaire refers to the goods description above, regardless of the commodity code under which they are exported.

## Like goods

In addition to seeking information about your company's export sales to the UK of the goods concerned, this pre-sampling questionnaire will also ask about your sales of like goods in your domestic market and to third countries. Any reference to '**like goods'** in this questionnaire refers to goods which are like the goods concerned in all respects, or with characteristics closely resembling them.

## Instructions

The Trade Remedies Authority (TRA) is responsible for investigating the allegation that Aluminium Extrusions from the People's Republic of China (PRC) are being exported to the United Kingdom (UK) at prices less than their normal value and that this dumping (sales at less than normal value) is causing injury to the UK industry for these goods.





# I - Why you are being asked to complete this pre-sampling questionnaire

We are seeking your cooperation as an **overseas exporter** to identify whether the alleged dumping has occurred and has caused injury to the UK industry. The information your company provides will help us determine a fair and appropriate response.

This pre-sampling questionnaire allows us to collect basic information and data about your company. If a large number of overseas exporters of the goods concerned from the People's Republic of China complete this pre-sampling questionnaire, we will use the information each one provides to help us decide which companies we want to sample for further investigation. If you are sampled, we will send you a more detailed questionnaire to complete.

If you are sampled for further investigation, we will provide you with a further detailed questionnaire. By submitting a completed detailed questionnaire response, you might become eligible for an individual anti-dumping amount, if we are recommending that measures apply following this investigation. Please refer to <u>Section C</u> for more information on individual anti-dumping amounts.

If you do not complete this pre-sampling questionnaire or the detailed questionnaire, you could be found to be non-cooperating. For more details on how this may affect you, please consult our <u>operational guidance on non-cooperation</u>.

## II – Who should complete this form

You should complete this form if you are an **overseas exporter** of Aluminium Extrusions exported from the People's Republic of China ('the goods concerned').

If you are not an **overseas exporter**, please complete either the relevant Pre-Sampling Questionnaire or the Contributor Registration Form.

#### III – Deadline for response

You will need to submit one confidential version and one non-confidential version of your pre-sampling questionnaire by the due date. Guangdong JMA Aluminium Profile Factory (Group) Co., Ltd. ("Guangdong JMA") is a Chinese producer of the goods concerned during the Period of Investigation ("POI"). During the POI, Guangdong JMA processed the goods concerned under processing trade method for its affiliated company JMA (HK) COMPANY LIMITED ("JMA (HK)") which then exported the goods concerned to the UK. JMA (HK) is also submitting a PSQ response to the TRA separately.

During the POI, Guangdong JMA processed the goods concerned under processing trade method for its affiliated company JMA (HK) COMPANY LIMITED ("JMA (HK)") which then exported the goods concerned to the UK. While in the table below, the CIF Value in GBP is the value of the goods concerned exported to the UK by JMA (HK) under processing trade method.

#### Answer:

Guangdong JMA submits that there is no existence of a particular market situation in the domestic market of the People's Republic of China. In addition, the scope of the investigation is too wide. For example, it is not clear that whether or not the products in a packaged kit ("finished goods kit") are included in the scope of investigation.
