The scope of this investigation

Goods concerned

This investigation covers optical fibre cables originating from the People's Republic of China, described as:

Single mode optical fibre cables, made up of one or more individually sheathed fibres, with protective casing, whether or not containing electric conductors. Hybrid cables, which are fitted both with optical fibres and electrical conductors, fall within the product scope of the investigation.

These optical fibre cables are currently classifiable within the following commodity code: 85447000. This commodity code is given for information only.

In this pre-sampling questionnaire, these goods will be referred to as 'the goods concerned'. Any reference to 'goods concerned' in this pre-sampling questionnaire refers to the goods description above, regardless of the commodity code under which they are exported.

The following products included under commodity code 85447000 are excluded from the scope of the investigation:

- (i) Multimode optical fibre cables.
- (ii) Cables in which all the optical fibres are individually fitted with operational connectors at one or both extremities; and
- (iii) cables for submarine use cables for submarine use are plastic insulated optical fibre cables, containing a copper or aluminium conductor, in which fibres are contained in metal modules.

Like goods

This pre-sampling questionnaire asks for information about your company's export sales to the UK of the goods concerned. This pre-sampling questionnaire will also ask about your sales of like goods in your domestic market and to third countries. Any reference to 'like goods' in this questionnaire refers to goods which are like the goods concerned in all respects, or with characteristics closely resembling them.

Instructions

I - Who should complete this form

You should complete this form if you are an overseas exporter of optical fibre cables originating from the People's Republic of China ('the goods concerned').

If you are not an overseas exporter, please complete either the relevant Pre-Sampling Questionnaire or the Contributor Registration Form.

II – Why you are being asked to complete this pre-sampling questionnaire

We are seeking your cooperation as an overseas exporter to identify whether alleged dumping has occurred, that the alleged exports were subsidised, and if this has caused injury to the UK industry. The information your company provides will help us determine a fair and appropriate response.

This pre-sampling questionnaire allows us to collect basic information and data about your company. If a large number of overseas exporters of the goods concerned from the People's Republic of China complete this pre-sampling questionnaire, we will use the information each one provides to help us decide which companies we want to sample for further investigation. If you are sampled, we will send you a more detailed questionnaire to complete.
