Imported into the United Kingdom from People's Republic of China

Initiation of a New Exporter Review

The Trade Remedies Authority (TRA) publishes the following Notice under regulation 67(7) of The Trade Remedies (Dumping and Subsidisation) (EU Exit) Regulations 2019 (the Regulations) to initiate a new exporter review into electric bicycles originating in the People's Republic of China (PRC).

This new exporter review concerns anti-dumping measures imposed as a result of investigation EU 2019/73 (AD643) into dumped goods from PRC. These measures were imposed from 17 January 2019. During the transition period the Secretary of State determined that the measures should be maintained in the UK from 1 January 2021. This is set out in this Notice – [Taxation Notice 2020/24](#).

The date of initiation of the review is **23rd June 2022**.

The collection of the anti-dumping amount for the review applicants' goods will be suspended pending the outcome of this review.

INITIATION OF A NEW EXPORTER REVIEW

An application to initiate a new exporter review has been lodged by

Jinhua Otmar Technology Co Limited, PRC ("Otmar")

Jinhua Seno Technology Co Limited, PRC ("Seno")
Unit 2, Building 16, No 168 Kechang Road, Qiubin Street Wucheng District, Jinhua City, Zhejiang Province, PR China, 321016.

The Application indicates that the Applicants:

- are not related to any overseas exporter:
 - who is subject to the application of an anti-dumping amount in respect of the Goods Subject to Review; or
 - who exported the Goods Subject to Review into the EU during the period of investigation; and
- did not export the Goods Subject to Review to the EU during the period of investigation; and
- are exporting the Goods Subject to Review to the UK.

The Goods Subject to Review are those which are listed below in this Notice of Initiation.

Having assessed the evidence provided in the Application, we consider that the Applicants have provided sufficient evidence substantiating the need for a New Exporter Review.

ISSUES FOR CONSIDERATION IN A NEW EXPORTER REVIEW

When conducting this review, we consider:

- whether the Applicants are overseas exporter;
- whether the Applicants exported the Goods Subject to Review into the EU during the EU period of investigation;

IMPORTERS AND EXPORTERS

The original review for this case was completed under EU 2019/73. The case has been transitioned to the UK on 1 January 2021 following [Taxation Notice 2020/24](#). The TRA are only aware of the exporters listed in the EU case, see Annex 1 below.

HOW TO TAKE PART IN THE REVIEW

Registration period

Anyone registering their interest after the registration period may not be able to participate fully in the review process.

Interested parties and contributors

Once registered, interested parties and contributors can submit comments on any issues relevant to the review through the [Trade Remedies Service](#).

Interested parties may include:

- the government of PRC;
- any overseas exporter or importer of the Goods Subject to Review;
- any overseas producer of the Goods Subject to Review;
- any trade or business association of overseas producers, overseas exporters or importers of the Goods Subject to Review;
- any producer of the like goods in the UK; and
- any trade or business association of UK producers of the like goods.

Like goods are goods which are like the Goods Subject to Review in all respects, or if there are no such goods, those which have characteristics closely resembling the Goods Subject to Review.

Contributors are those, other than interested parties, who have notified the TRA to advise that they would like to participate in the review.

THE GOODS SUBJECT TO REVIEW

The Goods Subject to Review are:

Cycles, with pedal assistance, with an auxiliary electric motor.

The Goods Subject to Review are subject to the following tariff classifications:

87 11 60 10 00

87 11 60 90 10

SUMMARY OF THE REVIEW PROCESS

The period of investigation for the review is 1 June 2021 to 31 May 2022.

The review will involve the following process:

- inviting parties to register their interest in the review;
- analysing information gathered;
- determining whether the Applicants are new exporters; and
- publishing a Statement of Essential Facts. On publication, we will set a period of time, which will be no longer than 30 days, during which parties will be able to comment on the Statement of Essential Facts

At the end of the review we will make a recommendation to the Secretary of State, which may include provision for the Applicants to be treated as new exporters and specify the anti-dumping amount to be applied to the Goods Subject to Review, or

we will terminate the review. The Secretary of State will then decide whether to accept or reject that recommendation.

- where that is not possible, a statement of reasons explaining why the information should be treated as confidential, and why it cannot be summarised.
