Safeguard measures on certain steel products

Initiation of a Transition Review of Safeguard Measures

Following the publication of a Notice of Determination,¹ the Secretary of State for International Trade (the 'Secretary of State') makes the following Notice to initiate a transition review of EU tariff rate quotas on certain categories of steel products under regulation 49 of the Trade Remedies (Increase in Imports Causing Serious Injury to UK Producers) (EU Exit) Regulations 2019 (the 'Regulations').²

The EU tariff rate quotas subject to review are set out in Commission Implementing Regulation (EU) 2019/159 of 31 January 2019 as amended by Commission Implementing Regulation (EU) 2019/1590 of 26 September 2019, Commission Implementing Regulation (EU) 2020/35 of 15 January 2020 and Commission Implementing Regulation (EU) 2020/894 of 29 June 2020 (the 'EU Regulation').³

The date of initiation of the review is **1 October 2020.**

Description of the goods subject to the Tariff Rate Quota and to this Transition Review

For a full description of the goods subject to the Tariff Rate Quota described in the Notice of Determination and the Annexes to this Notice, and subject to this transition review, please see column 2 ("Product category") of Annex 1 to this Notice.

Commodity codes

The commodity codes for the goods subject to review are listed in column 3 ("Commodity codes") of Annex 1 to this Notice.⁴

Tariff Rate Quota

Additional rate of import duty

Where the relevant tariff rate quota is exhausted, an additional duty at the rate of 25%, applicable to the net, free-at-the-frontier price, before duty, shall be applied on the product categories set out in Annex 1.

Products originating in certain countries

The origin of any product to which this notice applies shall be determined in accordance with the legislation in force in the United Kingdom relating to non-preferential rules of origin.

Where products originate from countries listed in Annex 3, they shall not be subject to the tariff rate quota, as provided for in regulations 46(6) and (7) of the Trade Remedies (Increase in Imports Causing Serious Injury to UK Producers) (EU Exit) Regulations 2019, unless the products from those countries are indicated in Annex 4 as not being exempt from the measures. Goods originating from a particular foreign country or territory may be excluded from the application of a tariff rate quota where the conditions in regulation 44(2) of the Trade Remedies (Increase in Imports Causing Serious Injury to UK Producers) (EU Exit) Regulations 2019 have been met.

Reasons for initiating the review

This review is a transitional review of EU tariff rate quotas initiated at the request of the Secretary of State.

Summary of the issues involved in the review

This is a review to consider whether goods belonging to each specified category of steel products were, during the investigation period considered by the European Commission in connection with EU tariff rate quotas, imported into the United Kingdom in increased quantities. This is also a review to consider, based on the information available for the Most Recent Period, if we should reduce or extend the application of the tariff rate quotas (as transitioned) and for how long.

Where these goods were imported, the review will consider whether:

- the importation of those goods in increased quantities would be likely to recur if they were no longer subject to a tariff rate quota;
- there would be serious injury to UK producers of like goods and directly competitive goods if goods belonging to the specified category were no longer subject to a tariff rate quota;
- the continuation of a tariff rate quota is necessary to facilitate the adjustment of UK producers of the like goods and directly competitive goods to the importation of goods belonging to that category; and
- whether an alternative tariff rate quota or the application of a safeguarding amount to goods belonging to that category would better meet the aim of preventing serious injury to UK producers of the like goods and directly competitive goods.

Like goods are goods that are like the goods subject to review in all respects or, if there are no such goods, goods that have characteristics closely resembling the goods subject to review.

Directly competitive goods are goods produced in the UK which are directly competitive with the goods subject to this transition review.

Period of investigation (POI)

The period of investigation is the years 2013 to 2017 reflecting the period of the original EU investigation.⁵ During the investigation, TRID will use data provided for the period of investigation to assess whether the safeguard measure on certain steel products should be maintained, varied or discontinued in the UK.

Most recent period (MRP)

The most recent period is 1 January 2018 to 30 June 2020. ⁶ During the investigation, TRID will use data provided for the most recent period to assess whether the safeguard measure on certain steel products should be reduced or extended in the UK.

Summary of the review process

The review will involve the following process:

- inviting parties to register their interest in the review;
- issuing questionnaires, where practicable, to:
 - interested parties and contributors who have made themselves known to the Secretary of State during the registration period; and
 - any UK producers, importers and overseas exporters, or their trade or business associations, that the Secretary of State considers relevant to the investigation;
- authentication to further assess and verify information;
- analysing information gathered; and
- publication of a statement of intended final determination.

The statement of intended final determination will include a summary of the facts considered by the Secretary of State during the investigation and will specify the period during which comments will be considered.

Having received comments from interested parties, we will make a preliminary decision on the review and the Secretary of State will then consider whether to give effect to that preliminary decision.

Interested parties may include:

- a government of relevant foreign country or territory;
- any overseas producer, oversees exporter or importer of the goods subject to review;
- any trade or business association representing oversees producers, overseas exporters or importers of the goods subject to review;

Data for this period is needed to help us consider whether it is appropriate to reduce or extend the period for which the safeguarding measure applies to the goods concerned in the review.

- any producer of the like goods or directly competitive goods in the United Kingdom; and
- any trade or business association representing UK producers of like goods or directly competitive goods.

Contributors are those, other than interested parties, who have notified us that they would like to participate in the review.

Information provided during an investigation may be treated as confidential. Anyone requesting that information be treated as confidential must demonstrate why, and provide:

- a non-confidential summary of that information; or
- where that is not possible, a statement of reasons explaining why the information should be treated as confidential, and why it cannot be summarised.

- For each of the product categories subject to the transition review, a part of each tariff rate quota will be allocated to the countries and territories specified in this Annex.

- The remaining part of each tariff rate quota, shall be allocated on a first-come-first-served basis, based on a tariff rate quota established equally for each quarter of the period of application.

- The drawings on each quarterly quota shall be stopped on the twentieth working day of the month following the end of the quarterly period. At the end of each quarter, the unused balances of the tariff rate quota shall automatically be transferred to the next quarter. No

unused balance at the end of the last quarter of each year of application of the definitive tariff rate quota shall be transferred.

- Where the relevant quota is exhausted for a specific country, imports from that country can access the residual tariff-rate quota for the same product category. This provision shall only apply during the last quarter of each year of application of the definitive tariff-rate quota. For some categories access to the residual quota in the final quarter for countries with a country-specific quota is capped, as set out in Annex 5.

Annex 5: Caps on residual quota use by countries with a country-specific quota

* cap for an individual country

These caps have been calculated following the methodology employed by the European Commission in its latest safeguard review:

- For product categories 5, 16, 20 and 27, countries with a country-specific quota will not be allowed to access the residual quota.
- For product categories 10, 12, 13, 14 15, 21 and 28, only access to a specific volume of the residual quota will be allowed, proportional to the volume allowed under the existing EU quota.
- For product categories 1 and 4B no exporting country will be allowed to individually use more than 70% of the residual quota.
- For product categories 2, 4A, 6, 7, 17, 19, 25B and 26, there will be no restrictions on access to the residual quota.
- As category 25Å is a global quota anyway, no cap on access to the residual quota will apply.
