

# Letter of authority template

# Guidance

This Guidance forms part of the Letter of Authority and must be submitted to the Trade Remedies Investigations Directorate (TRID).

# Who should provide this letter

This should only be used where a party has engaged a third-party representative, for example a lawyer or consultant, to prepare and submit evidence on its behalf. It is not required for companies submitting evidence directly.

# Why an authority letter is required

TRID requires a letter of authority to provide assurance that representatives providing information on behalf of a party during a trade remedies case have the authority to do so.

# Who should complete this letter

It must be completed by someone with legal authority to act on behalf of the party under the laws of the country where it is established or registered, for example, a company director.

# How to submit this letter

Upload your completed and signed letter on company-headed paper through our digital service platform, which you can find at: <u>https://www.investigations-trade-remedies.service.gov.uk.</u>

# What to do if your representative changes

You will need to promptly notify TRID and provide a new authority letter.
